



34th GYM FESTIVAL Trnava 11. – 12. september 2021

Safety Procedures for International Events During COVID-19 Pandemic

GENERAL INFORMATION

The aim of the Slovak gymnastics federation (SGF) is to offer a safe event and to protect the health of all participants during their stay in Slovakia.

We would like to inform you, that there are 4 countries taking part in **34th Gym Festival** in Trnava, with 39 athletes. It is not too much, but we believe, that we will organize nice and friendly competition – Slovak Open Championships for senior and junior categories and for girls Old Trnava Cup competition.

The organization is going well and the situation with Covid is stabilized. At the moment Slovakia is in the so-called "green zone".

ACCREDITATION

The accreditation will take place at the **CITY SPORT HALL, RYBNIKOVA 15, TRNAVA** upon arrival to the venue, **Friday, 10th SEPTEMBER, 2021 from 08:30 to 15:00.**

Please, respect the time. The accreditations will be handed out only **to the Head of Delegation.**

All delegations must deliver copies of: insurance declaration, passports, result of negative **PCR test** of all members (or **Quick test result**) or a proof of **vaccination.**

Due to the Covid 19 the planed diner for officials is CANCELLED.

Anyway, there are still requirements - either entering Slovakia or participating at the competition:

→To **ENTER** Slovakia:

- **Check the requirements for entering to Slovakia** according to the actual zone of your country - there are different requirements/ at:

(All information on the requirements for entering our country should be strictly followed so there are no problems when coming in Slovakia.)

- **Fill in the e-border form before arriving in Slovakia**

- **Print the letter from the Ministry of education of Slovak Republic** (I am sending it attached – it is in Slovak language). **This letter is support for the competitions so that you do not have to undergo quarantine.**

→To **PARTICIPATE AT THE GYM FESTIVAL TRNAVA**, we would like to forward the following information:

COVID-19 Guidelines:

- A proof of **vaccination** or negative **PCR test result** (done max. 72h before arrival) or negative **Quick test result** (done max. 24h before arrival) printed and readable in English, **must be provided for all participants at accreditation, on Friday, 10th September 2021.**
- only the EU approved vaccines are allowed at the event (BioNTech/Pfizer, Moderna, AstraZeneca and Janssen Pharmaceutica NV.)
- For the vaccine we request official documents for the respective full doses done (depending on the vaccine - 2 doses or 1) and the last vaccination should be at least 14 days.

Exceptions:

- **Children up to 12 years old** - no requirement. **They can enter without a vaccine and test.**
- Youths and seniors - 12 and above years old - vaccine or being already with COVID (up to 180 days).
- Besides the medical guidelines for the particular event, FIG also requires the participants to follow the standard precautions:
 - The FIG requires all participants, judges and officials to take standard precautionary measures, such as frequent hand-washing, wearing masks or face coverings at all times and keeping a physical distance of at least 1.5 metres whenever possible.
 - The only situation in which the safety distance does not have to be respected is when a coach provides assistance (catch, lead, spotting) during an athlete's performance. This phase must be kept as short as possible and the assisting person is obliged to wear a mask throughout.
 - Gymnasts do not need to wear a mask or face covering while they are performing at the training venue or on the FOP and keeping a physical distance of at least 1.5 metres whenever possible.

→RETURNING BACK HOME

- We suggest that each Nation checks the requirements to enter their country when going back from Slovakia.

If you will need, we can arrange for you Quick rapid AG test before departure.

Please, let us know if you request the testing by fill in the attached form. We need to have your request by Tuesday, 7.9.2021 the latest!

The price for Rapid Antigen Test is: 20 - 25 € euro per person
(the certain cost will depend from the company
which will arrange it)

When back home

We kindly ask you to monitor your health for ten days after returning. If you test positive for Covid19 please inform the LOC immediately.
